



## **7.Membership Secretary's Report:**

## **8.Reports on Mills:**

**a. Marsh Mill:** John Ingham from Melrose did not attend the meeting so there is no update about the repairs or the early termination of the lease.

Margaret was invited to a meeting of the Thornton Action Group which is now taking an interest in the future of the mill and are interested in liaising with us. Their united opinion is that W.B.C. should complete their 20 year lease.

Following complaints about the lack of access to the upper (machinery) floors, and contact with Councillor Ron Greenhough, a volunteer system is in the process of being put into place to support Graham James who is employed to work there.

Margaret has had a meeting with two officers from W.B.C. about publicity and beginning the process.

**b.Lytham Mill:** Work is in progress to obtain the timber necessary to construct the two new sails and repair the fantail, all damaged by the gales earlier in 2010. Work to be carried out by Joe Gillett and his son Nicholas.

**c.Little Marton Mill:** It has been agreed that work can be carried out to remove the mound at the side of the mill to prevent water ingress.

It is anticipated that the toilets will be removed and replaced with a better invalid toilet and also a domestic area created for the making of refreshments etc.

The amount of money for these and other projects has been reduced so priority has to be re-thought.

**d.Bunbury Mill:** Although a Trust has been formed to take over Bunbury Mill we have received no information as to progress.

## **9.Publicity**

Margaret - Table-top displays to publicise the group and encourage new members were held at – Lytham (History Day), UCLAN (Preston), CNWRS Lancaster University, Staining (Fylde).

A few items were sold and one new member gained.

A two day event is booked this year at a classic vehicle event near Fleetwood.
